

# Timetable for PIP replacing DLA

Updated: April 2015

## Timetable by date

### From April 2013

From 8 April, new claims to Personal Independence Payment (PIP) from anyone aged 16 to 64 were taken in the controlled start area in the North West and part of the North East of England. Postcodes affected were: BL, CA, CH (except CH1 and CH4-8), CW, DH, DL (except DL6-11), FY, L, LA (except LA2 7, LA2 8, LA6 2 and LA6 3), M, NE, PR, SR, TS (except TS9), WA and WN.

During this time DWP did not invite any existing Disability Living Allowance (DLA) claimants to claim PIP. Nor did DWP allow claims from DLA recipients who were seeking to make an early application to PIP.

### From June 2013

From 10 June, in addition to the area covered by the controlled start, new PIP claims were taken in all remaining areas of Great Britain.

DWP no longer accepts new claims for DLA from anyone aged 16 to 64, unless they are making a renewal claim from a fixed term DLA award that is due to expire before 17 March 2014. These claimants will re-claim DLA, and where entitlement continues will be invited to claim PIP at a later stage.

### From October 2013

From 28 October, reassessment of some existing DLA claimants started in Wales, East Midlands, West Midlands and East Anglia. Capita Health and Wellbeing are carrying out assessments in this area. DWP started inviting the following current DLA recipients to claim PIP:

- those with fixed period DLA awards ending on or after 17 March 2014 (reassessment activity starts approximately 20 weeks before existing DLA awards end);
- young people turning 16;
- those where there is a report of a change in the DLA claimant's health condition or disability; and
- existing DLA claimants aged 16-64 who wish to make a PIP claim.

### **From January 2014**

From 13 January 2014, reassessment areas extend to postcodes beginning: DG, EH, TD and ML in southern Scotland and parts of the borders.

DWP started inviting the following current DLA recipients to claim PIP:

- those with fixed period DLA awards ending on or after 2 June 2014 (reassessment activity starts approximately 20 weeks before existing DLA awards end);
- young people turning 16;
- those where there is a report of a change in the DLA claimant's health condition or disability; and
- existing DLA claimants aged 16-64 who wish to make a PIP claim.

### **From February 2014**

From 3 February, areas further extend to include postcodes beginning: CA, DL, HG, LA and YO in the north of England.

DWP started inviting the following current DLA recipients to claim PIP:

- those with fixed period DLA awards ending on or after 23 June 2014 (reassessment activity starts approximately 20 weeks before existing DLA awards end);
- young people turning 16;
- those where there is a report of a change in the DLA claimant's health condition or disability; and
- existing DLA claimants aged 16-64 who wish to make a PIP claim.
- further decisions on extending reassessment will be taken and communicated to the rest of the country in due course and will be informed by the experience of introducing reassessment in a gradual way first.

### **From November 2014**

From 17 November, areas further extend to include postcodes beginning: CH, HD, L and M.

### **From January 2015**

From 26 January, areas further extend to include postcodes beginning: DH, G, IV, NE, SR, WA and WN.

### **From February 2015**

From 23 February, areas further extend to include postcodes beginning: AB, BB, BD, DD, DN, EX, HX, KA, KY, LS, PH, PL, PO, PR, S, SO, TS, and WF.

### **From March 2015**

From 27 March, areas further extend to include postcodes beginning: BL, CW, FK, FY, HU, OL, SK, TA, TQ and TR.

### **From May 2015**

From 25 May, areas further extend to include postcodes beginning: BS; CB; CM; CO; DA; GL; MK; PA; RM; SN; SP and SS.

### **From June 2015**

From 22 June, areas further extend to include postcodes beginning: BA; BH, BN; BR; CR; CT; DT; E; EC; GU; HP; IG; LU; ME; OX; RG; RH; SE; SG; SW and WC.

### **From July 2015**

From 27 July, areas further extend to include postcodes beginning: AL; EN; HA; HS; KT; KW; N; NW; SL; SM; TN; TW; UB; W; WD and ZE.

### **From October 2015**

All the remaining claimants in receipt of a DLA award will be invited to make a claim for PIP. DWP will randomly select DLA claimants in receipt of an indefinite award or a fixed term award, and notify them about what they need to do to claim PIP. DWP will invite claims as early as possible from recipients who have turned 65 after 8 April 2013, when PIP was first introduced.

### **By late 2017**

All existing DLA claimants (aged 16 to 64 on 8 April 2013) will have been invited to claim PIP.

## **Timetable by age of claimant**

### **Under 16 years**

- New claimant: claim DLA
- Existing claimant: DLA continues. DWP will write before sixteenth birthday to inform when DLA will end and how to claim PIP (unless terminally ill)

### **Sixteenth birthday**

#### **From 8 April 2013**

- New claimant: claim DLA unless in controlled start post code (listed on page five)
- Existing claimant: DLA renewal claim

**From 10 June 2013**

- New claimant: claim PIP
- Existing claimant: DLA renewal claim

**From 28 October 2013**

- New claimant: claim PIP
- Existing claimant in Wales, East Midlands, West Midlands and East Anglia (see postcodes on p5): claim PIP if birthday on or after 7 October 2013.
- Existing claimant not in Wales, East Midlands, West Midlands and East Anglia: we may need to check their entitlement under the adult DLA rules – we'll continue to pay DLA until we've done so.

**From 13 January 2014**

- New claimant: claim PIP
- Existing claimant in postcodes beginning DG, EH, TD and ML in southern Scotland and parts of the borders: invited to claim PIP when reach age 16
- Existing claimant not in reassessment areas: we may need to check their entitlement under the adult DLA rules – we'll continue to pay DLA until we've done so

**From 3 February 2014**

- New claimant: claim PIP
- Existing claimant in postcodes beginning CA, DL, HG, LA and YO in the north of England: invited to claim PIP when reach age 16
- Existing claimant not in reassessment areas: we may need to check their entitlement under the adult DLA rules – we'll continue to pay DLA until we've done so
- Further decisions on extending natural assessment will be taken and communicated to the rest of the country in due course and will be informed by the experience of introducing reassessment in a gradual way first.

**From 17 November 2014**

- New claimant: claim PIP
- Existing claimant in postcodes beginning CH, HD, L and M invited to claim PIP when reach age 16

**From 26 January 2015**

- New claimant: claim PIP
- Existing claimant in postcodes beginning DH, G, IV, NE, SR, WA and WN invited to claim PIP when reach age 16

**From 23 February 2015**

- New claimant: claim PIP

- Existing claimant in postcodes beginning AB, BB, BD, DD, DN, EX, HX, KA, KY, LS, PH, PL, PO, PR, S, SO, TS and WF invited to claim PIP when reach age 16

**From 30 March 2015**

- New claimant: claim PIP
- Existing claimant in postcodes beginning BL, CW, FK, FY, HU, OL, SK, TA, TQ and TR invited to claim PIP when reach age 16

**From 25 May 2015**

- New claimant: claim PIP
- Existing claimant in postcodes beginning BS; CB; CM; CO; DA; GL; MK; PA; RM; SN; SP; SS invited to claim PIP when reach age 16

**From 22 June 2015**

- New claimant: claim PIP
- Existing claimant in postcodes beginning BA; BH, BN; BR; CR; CT; DT; E; EC; GU; HP; IG; LU; ME; OX; RG; RH; SE; SG; SW; WC invited to claim PIP when reach age 16

**From 28 July 2015**

- New claimant: claim PIP
- Existing claimant in postcodes beginning AL; EN; HA; HS; KT; KW; N; NW; SL; SM; TN; TW; UB; W; WD; ZE invited to claim PIP when reach age 16

**Aged 16 to 64 on or after 8 April 2013**

**From 8 April 2013**

- New claimant: claim DLA unless in controlled start post code (listed on page three)
- Existing claimant: DLA continues

**From 10 June 2013**

- New claimant: claim PIP
- Existing claimant: DLA continues

**From 28 October 2013**

- New claimant: claim PIP
- Existing claimant in Wales, East or West Midlands or East Anglia (see postcodes on p5): if change reported to DLA care or mobility needs or fixed term award due to expire on or after 17 March 2014, are being invited to claim PIP not DLA
- Further decisions on extending natural reassessment roll out will be taken and communicated to the rest of the country in due course and will be informed by the experience of introducing reassessment in a gradual way first.

**From 13 January 2014**

- New claimant: claim PIP
- Existing claimant in postcodes beginning DG, EH, TD and ML in southern Scotland and parts of the borders: if change reported to DLA care or mobility needs or fixed term award due to expire on or after 2 June 2014, will be invited to claim PIP not DLA

**From 3 February 2014**

- New claimant: claim PIP
- Existing claimant in postcodes beginning CA, DL, HG, LA and YO in the north of England: if change reported to DLA care or mobility needs or fixed term award due to expire on or after 23 June 2014, will be invited to claim PIP not DLA

**From 17 November 2014**

- New claimant: claim PIP
- Existing claimant in postcodes beginning CH, HD, L and M: if change reported to DLA care or mobility needs or fixed term award due to expire on or after 6 April 2015, will be invited to claim PIP not DLA

**From 26 January 2015**

- New claimant: claim PIP
- Existing claimant in postcodes beginning DH, G, IV, NE, SR, WA and WN: if change reported to DLA care or mobility needs or fixed term award due to expire on or after 15 June 2015, will be invited to claim PIP not DLA

**From 23 February 2015**

- New claimant: claim PIP
- Existing claimant in postcodes beginning AB, BB, BD, DD, DN, EX, HX, KA, KY, LS, PH, PL, PO, PR, S, SO, TS and WF: if change reported to DLA care or mobility needs or fixed term award due to expire on or after 13 July 2015, will be invited to claim PIP not DLA

**From 30 March 2015**

- New claimant: claim PIP
- Existing claimant in postcodes beginning BL, CW, FK, FY, HU, OL, SK, TA, TQ, TR: if change reported to DLA care or mobility needs or fixed term award due to expire on or after 17 August 2015, will be invited to claim PIP not DLA

**From 25 May 2015**

- New claimant: claim PIP
- Existing claimant in postcodes beginning BS; CB; CM; CO; DA; GL; MK; PA; RM; SN; SP; SS: if change reported to DLA care or mobility needs or fixed term award due to expire on or after 12 October 2015, will be invited to claim PIP not DLA

**From 22 June 2015**

- New claimant: claim PIP
- Existing claimant in postcodes beginning: BA; BH, BN; BR; CR; CT; DT; E; EC; GU; HP; IG; LU; ME; OX; RG; RH; SE; SG; SW; WC if change reported to DLA care or mobility needs or fixed term award due to expire on or after 9 November 2015, will be invited to claim PIP not DLA

**From 27 July 2015**

- New claimant: claim PIP
- Existing claimant in postcodes beginning AL; EN; HA; HS; KT; KW; N; NW; SL; SM; TN; TW; UB; W; WD; ZE: if change reported to DLA care or mobility needs or fixed term award due to expire on or after 14 December 2015, will be invited to claim PIP not DLA

**From October 2015**

- New claimant: claim PIP
- Existing claimant: if still getting DLA, will be invited to claim PIP (claimants who have reached age 65 or older will be contacted as soon as possible after October 2015)

**Aged 65 and over on 8 April 2013**

- New claimant: claim Attendance Allowance; unless DLA award ended less than one year ago, in which case re-claim DLA
- Existing claimant: DLA continues, as long as eligibility criteria met
